BEST FEMALE DIRECTOR AWARD OBJECTIVE

PNGID seeks to improve good corporate governance and elevate the importance of good directorship in meeting this goal. This award recognized outstanding directors who display a commitment to advancing their emerging careers as professional directors and to abiding by the standards of professional and ethical practice and behavior set by the Institute.

ELIGIBILITY

Nominated by their peers, the nominees are reviewed by a Selection Panel that includes prominent individuals from Papua New Guinea's director community. PNGID Board Directors are ineligible for nomination and cannot participate in the nomination process.

Individuals should have a prominent and distinguished career as a director. Nominees will be assessed against the criteria specified below.

CRITERIA

When making your nomination, please attach a brief explanation of your reasons for believing this individual should receive the award. You must provide short statements describing how the nominee meets any of the following award criteria that are listed below. Please provide examples to support the statements.

Selection Criteria. The selection considerations for this Award will include candidates' demonstration of relating to good corporate governance in any following areas:-

- 1) Effectiveness in strategic corporate business functions;
- 2) Contribution to board effectiveness;
- 3) Contribution towards managing change, risk and succession;
- 4) Leadership and other attributes and qualities, including continuing professional development for directors; and
- 5) Business ethics; and
- 6) Any other outstanding achievements relating to Board directorship

- agrees that PNGID may disclose the data collected in and appended to this form to the Selection Panel for selection purpose;

- agrees to supply further and better particulars when necessary;
- agrees to accept the award, in case of being selected;
- agrees to being publicized as an Awardee and to participate in the publicity programme arranged by the PNGID, in case of being selected; and
- Accepts the decision of the Selection Panel as the final decision.

BEST FEMALE DIRECTOR OF THE YEAR AWARD

If, after an Award is bestowed, any fact supplied in the respective nomination is discovered to be fraudulent or untrue, or the Awardee is proven to be associated with a fraudulent or dishonorable act, PNGID reserves the right, after consulting the Selection Panel, to withdraw the Award.
